the Assumption project. There is a lack of transparency on several fronts of the government's plans with foreign investors on the island; for instance, some claim they were not consulted on the Environment Impact Assessment (EIA). There are conflicting reports on the issue. Some say approval was granted early this year, yet we know the runway was already constructed. If the runway was part of the project, approval should have been obtained before the project's processes began. These contradictions indicate a deliberate attempt to conceal the truth about this project. We urgently need transparency, especially considering the potential environmental and national security risks.

QUESTION: The minister gave the impression that there was no need to bring the question to the National Assembly; United Seychelles **could have gotten the information** when pressured, they produced a reneeded through the Right of Access to Information Act. sential to shed light on all aspects of authorities are required to provide the information unless it falls under certain exemptions.)

ANSWER: We would like to make

two points on this. Firstly, the National Assembly has a constitutional obligation and power to seek information from the ministries. The Right of Access to Information Act was established for private citizens, not for the National Assembly, which can ask the government for any document, and the government cannot say the records are confidential. However, the Act is a crucial tool for promoting transparency and accountability in governance, allowing citizens to access information that can help them hold the government accountable. Second, it's crucial to address the government's record of lack of transparency. Let's take Travisory as an example. We (United Seychelles) asked for a copy of the contract, and dacted version. In the contract, we VAT. We learned they were not paying; therefore, who gave Travisory the authorisation not to pay VAT. When we use the Right of Access to Information Act, we do not get any information from the government, highlighting the need for more effective communication channels.

QUESTION: What do you think happened that has led to this situation on Assumption Island?

ANSWER: We (the people of Seychelles) were suddenly told (in 2021) that the President was officially visiting Qatar. It was a bit strange because we do not have a relationship per se with Qatar. Furthermore, a private Boeing was sent to take the President to Qatar. 

What is worrying is that we learn in the media that the two brothers have been sued in the High Courts in London, accused of financing Al-Nusra's terrorist activities. This group is affiliated with Al Qaeda. As Seychellois, we should be worried that we have a president who is brushing shoulders with people accused of financing terrorism. It is a threat to the security of our country, not just in terms of potential terrorist activities, but also in terms of our sovereignty and control over our own resources. We ask ourselves what is happening around Assumption Island. We heard the CEO who came here, but these people are the minor knots in that vast chain. The ones with power are the brothers on one side and the other, the President of the Republic of Seychelles, who is responsible for the project on Assumption Island. We tried to find the link between Ramkalawan and the brothers, and nobody wants to answer; any attempt to try and know the relation between the Seychelles politicians and these people is also stalled by the Speaker, whom we all saw put our MNA out of the National Assembly when he asked his question.

QUESTION: The minister said the project will benefit the country financially.

ANSWER: The minister has made many claims, most of which are untrue. For instance, we questioned him about the Government of Seychelles' association with individuals accused of financing terrorism. Was there due diligence by the concerned authority, such as the FIU? He said the documents were signed earlier this year, and there was no issue. He gave the impression that the court case occurred after January this year. This is false. Had he done due diligence, he would have known that this court case had been ongoing since 2021/2022. His response either raises questions about the competence of the FIU or the minister's honesty, which is concerning coming from a person we respect for his faith. They said Seychellois would get work on Assumption with this project. I don't believe they will employ Sevchellois; they will think Seychellois will leak what happens there. People will visit Assumption and then go to Aldabra. That is another deceitful thing to say. Going there costs around one million rupees. Who in Seychelles can afford to pay that sum to go there? This project could potentially exclude many Seychellois from experiencing their natural heritage, an injustice we cannot tolerate.



QUESTION: Dr Herminie, you mention Aldabra. On the group's website, we see pictures of Aldabra being promoted. What is your opinion?

ANSWER: This is arrogance. The group has decided to create a website, wwwaldabraisland.com, and they are advertising the islands in that area, such as Astove, Cosmoledo, Assumption, and Aldabra. But Aldabra is a World Heritage Site, and effectively, we see our islands are now in the hands of a group of people associated with terrorism, and it is dangerous. I ask if our sovereignty is not being compromised. The airport belongs to these people when we look at how things are. Will we be able to bring a group of children to visit Aldabra when a sheikh is there? The answer would be no. They will control the airport and the four islands, which is happening because of President Ramkalawan. Where's the SIF (Seychelles Islands Foundation? Who is promoting and defending Aldabra? It should be the SIF by a decree and not the group. Because of its uniqueness, UNESCO has a say because Aldabra was given to UNESCO. We risk losing control over our airport and islands, leaving us powerless and at the mercy of others, a situation we must prevent.

QUESTION: We heard the LDS MNAs defending the project on Assumption by comparing the island with La Digue. What is your take on this?

ANSWER: They made that comparison. It's like comparing apples and oranges. La Digue is a granitic island with a population, whereas Assumption is a coralline island with delicate biodiversity. In desperation, LDS tells us all sorts of stories.

QUESTION: There is an election next year. Since you are a presidential candidate, many people would want to know your plan for Assumption Island.

ANSWER: Firstly, we would like it if this project does not start. If anything, it would be good to know the public opinion on this matter, and the best way to do that is to allow Assumption to become an election issue. They will decide if they vote for a party promoting this project on Assumption. If they want it, then fine; it is their choice. However, the government should not rush to get money from this project before the election. When I sit and ponder over this matter, it is my opinion that a joint facility that was proposed with India is a better idea- on condition that the facility is managed by the Seychelles Defence Forces- with the leadership and control of a Seychellois commander would be more sensible given the illegal activities that take place in that area, such as poaching, drug and human trafficking etc. It would bring more benefits and safety to our sovereignty. We are told we will get only 20 million dollars (from the tourism project on Assumption), not upfront but in instalments. Minister Rangasamy said there would be a yearly rental, but he did not say how much. To acknowledge that the (tourism) project could also bring economic benefits to the country, but at what cost? This is a question we must all consider.

The other project would bring more money, and more importantly, given what is happening in our region, a Coast Guard facility will provide safety.

Furthermore, we would have gotten three thousand houses, a Government House to cut down on government rent, a new Police Headquarters, and a new Chamber for the Attorney General. Suppose there was a development suitable for Assumption. In that case, it should protect our territory, but that would happen only if the EIA is done by an independent organisation. This would ensure that the clearance is given without interference, providing reassurance and confidence in decision-making. Also, whether or not the Coast Guard can build a facility next to the tourism development. Have they leased the whole island, or is it just a part of it? We do not know. It is unlikely that the developers would allow a military facility on the island or any other development. This is why we believe this project needs to be stopped and should be a significant election issue. Let the people decide. It's their decision to make. We need to be cautiousour islands are being sold, and one of these days, we might wake up to learn that Mahe (the main island) has been sold. I've learned that Long Island is a case in a court in America due to a breach of trust. A sum of 12 million dollars is involved in this matter. There's also the allegation that Ste Anne Island is being sold.

The biased Speaker Roger Manicenne owes the United Seychelles, particularly Honourable Wallace Cosgrow, an apology for a gross injustice when he arrogantly asked Honourable Cosgrow to leave the National Assembly. On Tuesday, in the National Assembly, Honourable Cosgrow addressed two questions to the ministers, Rangasamy and Joubert. The Speaker did not allow Joubert to answer his part, which he claimed was an oversight. Yet, he did not reverse his decision to call Honourable Cosgrow back after asking him to leave. Minister Joubert had raised his hand to answer Honourable Cosgrow's questions, which queried whether the Leader of Government Business, who is also the chairperson of the Seychelles Island Foundation (SIF) Bernard Georges, was consulted in time on this eco-tourism project on Assumption Island. Georges was coincidentally absent for the Tuesday morning session of the National Assembly. Whatever his absence, Georges knew this question would arise because

he is privy to the Private Notice Question. Therefore, the public believes he was absent purposely to avoid any embarrassment. Any arrogant attempt to justify Georges' absence was pure stupidity. Despite the US Chief Whip's efforts to bring clarity to the situation and urge the Speaker to correct the injustice done to Honourable Cosgrow, Mancienne chose to ignore the issue. He continued with the session, even asking an LDS MNA to pose the next question, showing a blatant disregard for fairness and justice. This incident reveals the LDS' murky stance on the Assumption Island development. It also exposes the Speaker's deliberate act of allowing the executive to evade a crucial question. His protection of Bernard Georges, a friend and colleague in his LDS Party, is an apparent conflict of interest. Speaker Mancienne's resignation is imperative, as his actions have proven him unfit and lacking credibility for his role. His mistreatment of Honourable Cosgrow is a shameful mark on his record.

He was not the best candidate to win in 2020

The disappointment in Ramka's leadership is palpable, and the need for change is urgent—it's a call to action for every Seychellois citizen.

The public's growing discontent with Ramka's presidency is not just a sign; it's a loud and clear declaration of the need for change. The majority are gearing up to vote him out, a testament to the fact that he wasn't the best candidate to win the 2020 election.

He hides behind COVID-19 and geopolitical tensions to award himself the title of the most consequential president who needs re-election to do more damage as these problems escalate. Nobody is stupid, not the electorates who patiently wait to remove the mediocre president in office. He's proven to be so insincere that his party plummeted early in his presidency. They are now backing United Seychelles once more, turning their backs on Ramkalawan and a depleted LDS party who have wasted four years in power without making tangible progress in elevating the people's living standard. Instead, Ramka destroyed the prosperity of the people because he could not continue the progress they had inherited. It means the people who voted for Ramkalawan decided to cast United Seychelles aside at their own peril. But there was a silver lining. People have finally seen what the United Seychelles had been saying about Ramkalawan. He was an empty barrel who made the most noise but lacked the substance. He lacked what it takes to do the president's job. He was not qualified. He was not presidential material. He resonated like a loudspeaker in the National Assembly, at public rallies, and in street protests. That was all he had to offer. Somehow, the people joined the charade and followed the noises. They tossed him in the position, and Ramkalawan just froze. He cannot think on his feet, so he lets out verbal diarrhoea characterised by lies and deceit, and he becomes the object of ridicule on social media. Because he fears that he has nothing to offer and dreads the next campaign to be re-elected, he weaponises laws to ban hate speech. Ramkalawan's inability to handle the presidency has become increasingly evident. Instead of facing the challenges head-on, he has chosen to escape, often boarding planes and leaving the country when the going gets tough. This lack of responsibility is a slap in the face to the Seychellois people.

Though they may not admit it, even his ministers look frustrated and annoyed at how things are going—well, like us, they see that Seychelles is not going anywhere. Had the IMF and other international lenders not given us loans and had United Seychelles not left a significant sum in the reserves, Seychelles would have declared bankruptcy as early as 2021 when Ramkalawan told the nation to be more worried about getting a salary than overtime. He said there were

salaries for only three more months. Four years later, we look at how he spends on his personal travels and remunerations for politicians to keep them happy as they defend him; therefore, we ask him to share with the Seychellois workers. You want to take home twice the amount you are getting now, then raise the minimum wage to R10,000. Compensate the victims of the CCCL explosion and TRNUC.

If we are wrong and he is right that he is doing exceptionally well, as the LDS MNAs try to let on, that Ramkalawan is working really hard for Seychelles, then cough it up. Pay the Seychellois workers enough money to afford food and pay their bills. Give them their bonuses and extra salary. Reintroduce Long Service Allowance and pay them their entire overtime. What is good for the goose must be good for the gander, so share the money you spend in first-class and luxury hotels abroad.

LDS administration is anti-freedom

When we educate the people, politicians get mad and weaponise laws to curb our freedoms. - Censoring of political opposition



Recently, the National Assembly has started meeting for only one weekly session. Two sessions a week allowed for more comprehensive discussions and faster decision-making. Now, with only one session, crucial matters are being delayed, and the government's responsiveness is at risk.

sponsiveness is at risk. Linyon Demokratik Seselwa (LDS), the political party currently in power, had promised a more active role and, if elected, pledged to increase the number of sessions.

Three, possibly even four.

According to its leaders, there were too many things to discuss in the country, from economic reforms to social welfare policies. However, these discussions are now being postponed or ignored.

The party was not in power then, but it is now. It was elected in 2020 and will remain in power until 2025. What's more? With an absolute majority. It is in a position to dictate many things. Property tax?



Can you believe it? The government is planning to reintroduce property tax next year.

We've learned that the uncompassionate and greedy government is reintroducing property tax on all Seychellois landowners next year. For those who do not know, a similar tax called Poll Tax, a relic of the past was abolished by SPPF in 1977. Be vigilant. If the government offers a seemingly beneficial salary increase in the budget, it could be a ploy to recoup the money through increased taxes, such as in-

come tax (on your salary) and property tax. How many Seychellois own a plot of land? Many families live on Land Bank plots that they bought for R40,000 or R60,000 and even less under United Seychelles, which LDS has increased to R1.2 million. Acquired land through the Land Bank Scheme is around 6000, with more than 20,000 private properties.

As you strive to put food on the table for your family, be prepared for an additional financial burden in the form of property tax.
