# The danger of an unfit President

Enabling and protecting wealth concentration

His unwavering defence of these actions, which are pushing the middle class into poverty and the most vulnerable into deeper destitution, raises urgent questions about the need for accountability in our governance. This disregard for the nation's well-being underscores the gravity of the situation.

The issue involves wealth concentration among a small circle of the President's associates, who have invested in private companies and banks. Dr Herminie asserts that the Pension Fund should have purchased these shares, which could have strengthened the Fund's finances and reduced the Pension Age back to 63. He challenged Ramkalawan's claims that the shares could not be sold to the Pension Fund due to a lack of correspondence banking. "Does the company that bought those shares have correspondence banking? Is it a bank?" Dr Herminie questioned. "It baffles me that the President is unaware that the Pension Fund holds 30% shares in Al Salam Bank, 9% in the Seychelles Commercial Bank, and shares in various international banks."

Dr Herminie expressed disappointment that some individuals, who were once considered people of integrity and have

contributed to our country, are now motivated by greed. Instead of safeguarding the populace and acting in the nation's best interest, the President is siding with the elite, ignoring the critical state of our economy and social sectors. By doing so, he is paving the way for these individuals to invest in lucrative opportunities that ultimately lead to their control over the national economy.

"If this is not inside dealing and corruption, what is it?" Dr Herminie asked.

"Ramkalawan hastily called a press conference to present half-truths aimed at creating confusion", remarked Dr Herminie. Ramlawan should be aware that the US will investigate "several of his administration's decisions," Dr Herminie pointed out, "We cannot file a case with the Anti-Corruption Commission of Seychelles, which has been weaponised by the state."

# After all the empty promises, why isn't he ashamed?



# United Seychelles' plan to revitalise tourism

In light of the alarming 0.5% increase in tourist arrivals in 2024 compared to 2023, a situation that has sparked urgent concern among industry stakeholders and the Seychellois public who depend on tourism as their primary source of income, Dr Patrick Herminie, President of the United Seychelles Party and a presidential candidate for the upcoming election, has announced a few immediate and crucial decisions to rejuvenate the tourism sector once in power.

Key measures proposed include abolishing the Travisory in Seychelles and reducing the levies and taxes currently burdening tourists and the tourism industry, especially smaller hotels and guesthouses. Dr Herminie emphasised, "There are too many taxes in tourism, driving visitors to other destinations. We will have to look into it and reduce it gradually, starting with the guesthouses. While generating R170 million, we are losing R1.3 billion due to existing taxes and bureaucracy." He pointed out that tourists are penalised with taxes if they fill out their applications late.

Dr Herminie has also drawn attention to the detrimental effects of negative publicity, compounded by the escalating crime rates in the country. He has also addressed concerns about racial



profiling, sharing a disturbing account from a tourist who had an unpleasant experience upon arriving in Seychelles. He proposed that if Travisory aids border management, the United Seychelles government would develop e-border solutions. Other measures will focus on enhancing Seychelles' visibility, which includes re-establishing the Seychelles Tourism Board. This board will take responsibility for promoting tourism while the government facilitates its operations. Dr Herminie noted that large hotels, typically run by entrepreneurs, have an easier time marketing themselves than small guesthouses that heavily rely on support from government tourism entities.

Furthermore, he mentioned ongoing discussions with aviation experts on

transitioning the national airline back to an international carrier rather than just a regional one. Dr Herminie states, "Seychelles needs flights from Europe for the survival of our tourism industry." Noting that the current capacity is 600,000, only half of that capacity is being utilised—including returning citizens and expatriates—Dr. Herminie called for improvement.

He has also identified a lack of engaging activities for tourists, including those arriving on cruise ships, who often have little to do. United Seychelles is dedicated to creating various activities to entertain visitors and benefit local artisans, artists, and businesses, enhancing the overall tourist experience. We are committed to supporting and valuing our local busi-

nesses in the tourism sector.

Dr Herminie strongly criticised the current government's approach, stating that it prioritises larger establishments at the expense of small guesthouses. He remarked, "These small guesthouse earnings remain within the local economy, but how much is the country gaining from the larger establishments? This approach must change to improve our tourism industry and the local economy."

President Ramkalawan stated in a foreign interview that he is focused on attracting high-end tourists rather than backpackers. He should not be mad if we point our finger directly at him—his words are destroying the guest-houses.

# Never a dull moment with an ill-advised President

Aldabra Atoll.

During the live press conference, the President staunchly defended these appointments, praising the Hassan brothers as qualified individuals who went to school and could perform their jobs. However, in the past, he has publicly accused United Seychelles of nepotism for having individuals like Dr Herminie and his late brother William Herminie, Glenny Savy and David Savy, as well as former President Faure and his brother, Ambassador Barry Faure, in government positions. Don't these individuals also have educational backgrounds? As far as we know, they, too, worked in Seychelles. There is an

apparent inconsistency in your administration that many Seychellois can detect, a defence that should be met with scepticism.

So, why use the media to score political points on such issues, Mr. President? You have too much time on your hands. Why preach to the media when it should be their responsibility to fact-check the claims and manipulations presented during your live press conferences and not the press releases from your opponents, especially Dr Herminie, who will defeat you in the polls? 
#### United Seychelles Calls for Transparency Following Electoral Commission Chairman's Resignation
